Your Rights as a Participant

Declaration of Consent to Use Your Data Collected during the Test

If you wish to participate in the Test, you need to give Medela permission to use your answers given during the Test ("Answers") and we want to make sure you know exactly how we want to use your Answers.

You hereby grant Medela a royalty-free, non-exclusive, transferable and irrevocable commercial right to reproduce and modify your answers in any form (including, but not limited to, video, Internet contributions, reproductions, images, e-mails, publications and distribution), either through our own services or through third party services, worldwide through any medium now known or later developed, and without limitation or restriction.
